Answer:

The Department of Finance signed a 4 year agreement with ASG Limited, valued at \$29m (GST exclusive) for the provision of a range of ICT deliverables “As a Service” on 24 December 2015. The “As a Service” model does not have individual unit hardware prices and unit costs have not been specified. ASG’s proposed solution was evaluated as an innovative, comprehensive and value for money proposition for the Department. In addition, ASG’s experience in delivering similar services to Government agencies provides Finance with confidence of a successful outcome for the Department.

These deliverables include the design, build, deployment and support for:

- A new Windows 10 operating environment;

- Desktop hardware, laptops and tablets;
 - Office productivity tools;
 - Email and collaboration tools;
 - Mobility solutions;
 - Wireless access; and
 - Unified communications including phones and video conferencing.

 - b) These are being provided under a managed service arrangement and are not costed as a separate item.
 - c) 2,614 currently in use.
 - d) Finance hardware assets are disposed of using the most practical and economic method, in accordance with operational guidelines. As a general rule, Finance's ICT assets are disposed of via auction processes, where it is economical to do so. In cases where an item of property has become worthless, the disposal method of dump and destroy is usually used.
