The Prime Minister, the Hon Malcolm Turnbull and I recently wrote to Mr Sean Gordon and Mr Noel Pearson in their capacity as Co-Chairs of the Empowered Communities Indigenous leadership group expressing our thanks for the Empowered Communities report and outlining a regionally focussed response from the Australian Government.

The response outlined in my letter to Messrs Gordon and Pearson focusses on working with each of the Empowered Communities leaders to jointly agree on priorities and practical projects that promote Indigenous responsibility in their regions. We have a particular interest in school attendance and attainment, economic development and employment and community safety, objectives that I know are shared by your Government.

The Australian Government has also indicated that it is prepared to consider funding support for Backbone Organisations to implement and deliver Empowered Communities arrangements in each region. This would be negotiated between the Department's Regional Managers and Empowered Communities leaders in each region, taking into account the varying needs, challenges and opportunities present in each location.

Your Government was represented on the Steering Committee oversighting the development of the Empowered Communities report. I understand there has been further contact between officials as the Australian Government has considered its response to the report.

It is clear that a better engagement between all levels of government and Indigenous people and a stronger role for proactive Indigenous leaders is essential if we are to achieve the ambitious targets that both our governments have committed to under the Closing the Gap agreement. I believe that Empowered Communities offers a positive opportunity for governments to achieve this. I am also conscious that there are other relevant initiatives being progressed by state and territory governments and I am keen to ensure that Empowered Communities complements rather than duplicates these other reforms. Where there are other locally led reform initiatives we are also keen to engage with these in conjunction with any work we are doing with Empowered Communities. It will be important that analysis of the progress of implementation of Empowered Communities is iterative and ongoing.
