Please provide a list of properties transferred to the ILC from other government authorities, including the Indigenous Land Fund.

**Answer:**

The only properties transferred to the ILC from another government authority are the properties that were previously owned by the now defunct Aboriginal and Torres Strait Islander Commission (ATSIC). When ATSIC was abolished those properties vested in the ILC pursuant to the *Aboriginal and Torres Strait Islander Commission Amendment Act 2005* (Cth) and the Declaration dated 23 March 2005 of the then Minister for Immigration and Multicultural and Indigenous Affairs, Amanda Vanstone, titled *Aboriginal and Torres Strait Islander Commission Amendment (ATSIC Abolition Day—Assets and Liabilities) Declaration 2005*, Schedule 4, Part 1. A list of these properties is attached.

No other properties have been transferred to the ILC from other government authorities.
