Question:

- 1) At the Senate Estimates it was advised the budget for the Cities Division is \$4.971 million. Could a breakdown of this budget be provided? How much will the Cities Division receive over the forward estimates?
- 2) It was also advised at Senate Estimates that this budget included any type of expertise that might need to be procured. Could a list of all procured expertise since the establishment of the Cities Division be provided, including the costs associated with each.
- 3) Has the Cities Division engaged any contractors since its establishment? If so, for what purpose. Please details all associated costs.
- 4) At the Senate Estimates it was also advised that the Cities Division has nine agencies and 11 staff. Please provide a list of all staff, including those working on cities in PM&C, by role, level, function, section.
- 5) Please provide a list of all staffing changes including overall numbers, date, since the last Estimates.
- 6) Please provide an organisational chart.
- 7) Who is in charge?

Answer:

- 1) The \$4.971m budget consists of:
 - o \$2.515 million in supplier expenses (including secondee payments)
 - o \$2.456 million in employee expenses.

Funding for future years will be decided in the Budget process.

- 2) A list of procured expertise since the establishment of the Cities Division within the Department of the Prime Minister and Cabinet is at <u>Attachment A</u>. For the purpose this question, expertise is defined as consultancy services that have all of the following characteristics.
 - The services involve the development of an intellectual output that assists with agency decision making.
 - The intellectual output reflect the independent views of the service provider as opposed to the agency's views.
 - The intellectual output the sole or substantial element of the procurement, in terms of relative value and importance.
- 3) A list of contractors engaged since the establishment of the Cities Division within PM&C is at Attachment B. For the purpose of this question, contractors are defined as goods and services acquired for the Commonwealth's own use or for the use of third parties.
