Senator GALLAGHER: In relation to the education and training portfolio, on page 79 of budget paper No. 2. I think these are similar questions to the one Senator Ludwig just asked ... I am really just trying to get an understanding of the different elements relating to the savings there—the breakdown. We will achieve savings over five years. Is that able to be provided, the breakdown of the 131?

Senator Cormann: Consistent with the approach taken in relation to other measures, we can take that on notice, but just by way of background: the government initiated and has conducted functional and efficiency reviews, so far, into the health and education departments.

Senator GALLAGHER: If we could get a breakdown of those, that would be very useful; and the same for the Department of Human Services. I think they are covered on 115. **Senator Cormann:** Yes, we will do that.
