**Senator GALLAGHER:** I have a question on what I understand is an update, so it must have come up at a previous hearing, on the top 20 fastest-spending programs in the budget.

**Senator Cormann:** I think there is actually a table, isn't there? To the extent that it is not publicly available, we will see whether we can provide you with some information on notice. There is some information about expenditure.

**Ms Huxtable:** It is page 5-13 of BP1.

**Senator Cormann:** This is not quite what you have just asked.

**Ms Huxtable:** Top 20 ranked by expenses 2015-16.

**Senator Cormann:** Is that it?

**Ms Halton:** Yes. Table 3.1?

**Senator GALLAGHER:** Yes.

**Ms Huxtable:** Is that what you asked for?

**Senator GALLAGHER:** I did.

**Senator Cormann:** These are the top 20 programs by expenditure. I understood that you asked about the top 20 fastest growing.

**Senator GALLAGHER:** Yes.

**Senator Cormann:** We might take that on notice.

**Senator GALLAGHER:** They are different, are they? I see, these are the top 20. These are the largest; not necessarily the fastest growing.

**Senator Cormann:** There is information in a separate table, which I am trying find, not about programs but about portfolio areas.

**Senator GALLAGHER:** Okay, that would be great.

**Senator Cormann:** If you go to table 3 in Budget Paper 1, page 1-9 you will see the expenditure growth trends across the various portfolios.

**Ms Halton:** We would need to give it to you on notice in terms of the specific question you asked to begin with, but this gives you a feel.
