With reference to the answer to 2016-17 Additional Estimates question on notice 82, on what basis is a group that comprises three Government members of the House of Representatives (Christensen, Entsch, Marino), three independent members of the House of Representatives (Katter, Wilkie, McGowan), four minor party and independent senators (Leyonhjelm, Lambie, Xenophon, Day) and only one Opposition member of the House of Representatives (Fitzgibbon) and no Government or Opposition senators "representative", as stated in part 3 of the question?

Who nominated or chose the members of this group?

Why have existing bodies, such as this committee, or the respective house committees of both chambers, not been utilised to provide feedback?

How can such limited consultation be adequate and fulfil the "detailed consultation" that part 4 of the answer identifies was a criteria of the contract?

No other information or detail in support of the approval to engage with elected officials is available to the department as the Director involved has since left the department.

This group selected for engagement provided a representative sample of elected representatives, however many of these declined to participate in the process.

The final group of stakeholders who were consulted, however, did provide a representative sample for the building, including Senators and Members, the respective House departments, Department of Finance, the Parliamentary Budget Office and DPS.
