Question:

There was a report in *The Australian* on 17 October 2013 ("Ministers told to rein in spending as Mathias Cormann cracks down on grants") that the Government is taking \$975 million over four years from a "series of redirections of unspent money". Can you provide a list of all the programs from which these unspent funds were coming from?

Answer:

Savings of \$1.1 billion are included in MYEFO from accepting most of the offsetting savings identified by the former government to fund its election commitments and by not proceeding with various uncommitted discretionary grants or spending commitments announced by the former government in the 2013 Economic Statement or before the 2013 PEFO. The measures are published in the 2013-14 MYEFO.
