3. Finance uses Windows 7 and Vista under a Core Desktop Licence (CDL) model. A CDL provides a suite of commonly used Microsoft desktop products including the operating system. The CDL is purchased under the Microsoft Volume Sourcing Arrangement II.

Costs for the entire Microsoft Volume Sourcing Arrangement (VSA) for Finance are estimated at \$1.31 million per financial year through to 2015-16.

Licences for the operating system are already owned perpetually (since 2008), with an ongoing software assurance arrangement (included in the above costs).
