Senator SMITH: If you have other statistics with regard to the industrial action, I would be grateful to see them. Perhaps you could provide them on notice. What time of the day do people participate in the industrial action? I am curious to know what time of the day on 15 September, what time of the day on 24 September, what time of the day Human Services participated in industrial action and what time of the day the department of tax participated et cetera.

Ms Foster: From memory, there were a couple of different stoppages. There was a one-to-five and a five-till-nine stoppage in the Department of Human Services.

Senator SMITH: If you could provide me that information as well?

Ms Foster: Yes.

Senator GALLAGHER: If you are providing that information to Senator Smith, I think the results for those

agencies where ballots have been held on an offer—including the participation rate, which is very high from my

reading of the results—should be included in the answer, if that would be okay.

Answer:

The Australian Public Service Commission (the APSC) keeps records of protected industrial action as reported to it by agencies.

Agencies are asked to provide the APSC with copies of all notices, and to report on the participation and impact of stoppages.

There have not been many significant stoppages, with most being for 1-4 hours. Most protected industrial action this bargaining round has been partial work bans. Agencies have reported that the impact of stoppages has been low, with low levels of participation.

The APSC routinely collects participation data only for major work stoppages.
