Senator SIEWERT: You cannot tell us—outside the grant process—against each of the IAS grants. You have given us the global budget, as I understand it, for the non-grants process. Ms Andrew is nodding at me.

Ms Edwards: What numbers we do have—we can tell you what is legally committed under each program, at the moment, and that amount would include everything that has been legally committed—that is, everything contracted under the grants round plus outside the grants round, in the current financial year. These numbers do not distinguish between one or the other.

Senator SIEWERT: What is going through my head is that the number you have given me, in fact, is not against the financial year; it is given against 30 September. So it is 15 months.

Ms Edwards: Yes.

Senator SIEWERT: That is where I am now struggling. If you give me the financial year, I am missing a chunk of expenditure. Do you see where I am—

Ms Edwards: Yes. I do not have the 2014-15 numbers with me.

Senator SIEWERT: We are comparing apples with oranges. Perhaps you could take it on

notice.

Ms Edwards: Yes. Mr Tongue: Certainly.
