Senator Collins asked the following written question from the 24 February and 27 March 2015 hearings:

- 1. On 26 March the Attorney-General announced '\$25.5 million over two years to 30 June 2017, of funding for Legal Aid Commissions, Community Legal Centres and Indigenous legal service providers'. Please provide a breakdown of when and where this funding will be allocated.
- 2. Have any individual CLCs been notified of the restoration of their funding? If not, when will this take place?
- 3. When will CLCs receive the restored funding promised?
- 4. Does this figure include the funding for the Yarra Ranges CLC announced in March by Tony Smith MP?

The answer to the honourable senator's question is as follows:

1. A total of \$25.5 million in supplementary funding will be reinstated over two years from 1 July 2015. Funding will be returned to the following programmes:

Reinstated funding for the Legal Aid Commission – ECCCF will be returned to the appropriation held by the Attorney-General's Department. The ECCCF is administered by the Department, pursuant to Guidelines, to reimburse State and Territory legal aid commissions for the legal costs of representing defendants in expensive Commonwealth criminal trials.

From 1 July 2015, funding (including reinstated funds) for the ILAP will be distributed under a new funding allocation model developed by a consultant engaged by the Attorney-General's Department.

Reinstated funding for the CLSP will be distributed to 61 community legal centres listed below:
