What are the total costs to the Department associated with the litigation over the detention of 157 asylum seekers in CPCF v Minister for Immigration and Border Protection & Anor?

Under the Memorandum of Understanding between the Independent State of Papua New Guinea and the Government of Australia relating to the transfer to, and assessment and settlement in, Papua New Guinea of certain persons, and related issues Australia has met the legal costs of the Government of PNG in relation to constitutional and human rights challenges. Australia has provided legal support in the sum of \$393,584 in the Cannings' inquiry and related matters. Funds are provided to the Government of PNG legal representative under a pre-payment arrangement. The legal representative is yet to draw on the final \$90,768 pre-payment extended in May 2014.

The Department's total onshore external litigation and offshore legal proceedings expenditure associated with asylum seeker and refugee litigation (protection visa litigation) over the last three financial years was \$32,236,032.

Under the terms of the *Memorandum of Understanding between the Republic of Nauru and the Commonwealth of Australia, relating to the transfer to and assessment of persons in Nauru, and related issues,* the Government of Australia has met all legal costs and associated charges in relation to the July 2013 riot cases. To date, \$788,947 has been expended to support this court process. A breakdown by financial years is provided in Table 5 below:

The total external litigation expenditure incurred by the Department in defending S297/2013 v Minister for Immigration and Border Protection & Anor was \$293,036. This includes professional fees, counsel and disbursements (excluding GST). External legal expenditure associated with CPCF was covered by Comcover, we also note a costs order was made in favour of the Commonwealth when the decision was handed down.
