 - 3. If so, list the itemised cost for each item of expenditure
 - 4. If so, who conducted the works?
 - 5. If so, list the process for identifying who would conduct these works
 - 6. If so, when are the works expected to be completed?

The answer to the honourable senator's question is as follows:

The portfolio's response to this question is set out in the table below, with the exception of ASIO (for security reasons it would not be appropriate to comment publicly on the specific refurbishments, upgrades or changes to ASIO's buildings or facilities) and ACC (which is moving to use the Australian Tax Office as its provider of property services; the recent relocation of the ACC Canberra office is therefore reported within the Treasury portfolio response).
