Can you please update the committee on the number of student visas cancelled to date. Can you break that down into:

source countries

raw numbers

percentage of visas withdrawn

grounds for action

types of providers

Can you provide the number of student visas cancelled in the last 6 months of 2014 compared to the last 6 months of 2015

How many student visas were cancelled in the 2015 calendar year (note 12,289 last year from Jan to September)

*Answer:*

There were 9,263 student visa cancellations, both onshore and offshore, in the period 01 July 2015 to 31 January 2016.

The following table provides figures of student visa cancellations in the period 01 July 2015 to 31 January 2016 by source country, represented as both raw figures and as a percentage of the total:

There were 15,716 student visa cancellations, both onshore and offshore, in the 2015 calendar year, compared to 7,027 in the 2014 calendar year. Note that these figures exclude cancellations of visa subclass 580 (Student Guardian).

The significant increase in student visa cancellations between the comparative reporting periods can primarily be attributed to the Department's introduction in early 2015 of a revised process for identifying long-term, offshore students using automated batch processing. Batch processing enables the Department to cancel a higher number of visas per month, for students who are no longer residing in Australia.

*Note that all figures provided in the above response were extracted from Departmental systems as at 10 February 2016. As data has been drawn from a live systems environment, the figures provided may differ slightly in previous or future reporting.*
