The Departments response to questions 1-7 are at attachment A, other than for the Australian Government Solicitor (AGS). AGS maintains a separate accounting system that is designed specifically for use in legal practices. As its accounting system does not separately capture information of this kind, it would require an unreasonable diversion of resources to respond to this question.
