Answer:

Visa condition 8202 of Schedule 8 of the *Migration Regulations 1994* (the Regulations) is a mandatory condition imposed on all primary student visa holders. This condition broadly covers enrolment, with 8202(2)(c)(ii) specifically requiring students to achieve "satisfactory course attendance".

The following table provides percentages of student visa cancellations, as a total of all student visa cancellations, made under section 116(1)(b) for breach of condition 8202.

Visa conditions 8104 and 8105 of Schedule 8 of the Regulations are mandatorily imposed on secondary and primary student visa holders respectively. Amongst other things, they impose a limit of 40 hours of work that those visa holders can undertake in a given fortnight (subject to certain exceptions).

The following table provides percentages of student visa cancellations, as a total of all student visa cancellations, made under section 116(1)(b) for breach of conditions 8104 and 8105.
