- details of the applicant's qualifications, training and skills relevant to the proposed nominated job in Australia
- details of English language testing undertaken.

Nomination application form:

- sponsor's details, including Australian Business Number (ABN)
- nomination details including details of the position to be filled, evidence of labour market testing (if applicable), terms and conditions of employment, description of the position
- position certifications (genuine position, market salary, employment contract)
- personal details of the nominated person and any accompanying family members, including identifying information and contact details.

Sponsorship Application Form:

- details of the business, including location of the business and the business structure, business name, ABN, details of all participants of the business, business annual turnover
- reasons for proposing the number of job positions the business intends to nominate
- industry sector the business is operating in
- any adverse history (if applicable)
- accredited status details (if applicable)
- details of training, including the gross expenditure of the business on training in the last 12 months
- information on whether the business is intending to sponsor workers to establish a business in Australia or to fulfill a contractual obligation (overseas businesses only).
