Senator Kakoschke-Moore, Skye asked the following question on 28 August 2017:

Senator KAKOSCHKE-MOORE: Attorney, I think you referenced this a little earlier about support for families experiencing domestic violence in the context of disputes in the Family Court: can you point to which Family Courts will receive more duty lawyers through this particular program?

Senator Brandis: I will take that on notice.

Senator KAKOSCHKE-MOORE: If that answer could include a state-by-state breakdown, that

would be great.

Senator Brandis: Yes.

The response to the honourable senator's question is as follows:

The Family Advocacy and Support Service (FASS) is an initiative delivering \$18.5 million over three years (2016 – 2019) for legal aid commissions to provide enhanced services to families experiencing family violence. The FASS expands the existing duty lawyer capacity at family law court registries and integrates trauma-informed social support services. A breakdown of service locations and funding is below.
