When was the Distinguished Talent Visa introduced?

The Distinguished Talent visa was originally introduced on 1 September 1994 as the Distinguished Talent-Australian Support (Subclass 124) visa. On 1 November 1999, the Migration Regulations 1994 were modified to incorporate the Distinguished Talent visa (subclass 858) for onshore applicants and the program was expanded to include applicants who had assisted Australia in security matters.

How many visas have been issued under this program?

From 1 September 1994 to 31 May 2017 a total of 3594 visas have been issued, in both visa classes, for both primary and dependent applicants.

Please list the number of visas issued each year for the past five years on record? How many applications for DTVs has the Department received and rejected over the past five years?

The below table relates to both primary and secondary applicants for both the Distinguished Talent (Subclass 124) visa and the Distinguished Talent visa (subclass 858).

Australia's permanent migration programme is set on an annual basis as part of the Budget process. When setting the size and composition of the programme, a wide range of factors are considered including stakeholder views, immediate and forecast long-term social and economic trends as well as the family reunion needs of Australians. Planning levels are reviewed throughout the programme year to ensure they remain responsive to the economic environment. Australia's 2017-18 permanent Migration Programme planning levels were set at 190,000 places with 200 places allocated to Distinguished Talent visas.
