Operating Systems, Contractual Arrangements and Ongoing Costs for DIBP and ACBPS

DIBP and ACBPS use Windows 7 Enterprise as their operating system for onshore assets. Windows 7 Enterprise is provided under Microsoft Core Desktop Licensing, which is managed by the Department of Finance. The operating system component was last listed as costing \$27.57 per user per year for onshore assets.

The operating system and all software costs for overseas assets used in DIBP are managed by the Department of Foreign Affairs and Trade. DIBP is unable to allocate a direct cost to the operating system for these assets.
