Can you provide the committee with an update on how you will undertake to improve coordination among your multiple stakeholders to tackle the issues of plant biosecurity and management of fruit flies?

Answer:

Plant Health Australia (PHA) works with our multiple stakeholders daily. These include but are not limited to, the Australian Government, all state and territory governments and 35 plant industry peak bodies, as well as a number of Rural Research and Development Corporations as PHA members. Specific information can be found on the PHA website at http://www.planthealthaustralia.com.au/.

Regarding management of fruit flies, this was partly addressed in Greg Fraser, Executive Director and CEO of PHA's response at the hearing and is captured in proof Hansard pages 90 and 91. In addition however PHA has now employed a National Manager for the Fruit Fly Council and finalised membership of the Council. The Council is currently comprised of 6 grower and industry representatives from WA, SA, Victoria, NSW and Queensland who are engaged with a range of fruit fly impacted commodities. There are also a number of government regulator and policy representatives as well as research and development providers. The council has an independent chairman. As well at the Fruit Fly Council initiative, PHA works with government and industry parties on a number of specific fruit fly projects. All these activities have the aim of improving national co-ordination and ensuring that fruit flies are no longer a constraint to sustainable production or a significant barrier to national and international trade.

What were the main reasons why PHA decided not to proceed with re-location with AHA?

Has PHA signed a new lease? Where are your new premises or have you decided to stayed in your original premises?

Answer:

The primary reason that Plant Health Australia (PHA) and Animal Health Australia (AHA) did not co-locate was that PHA could not identify an option that was cost beneficial. Once the decision was made not to co-locate, PHA initiated negotiations with the current landlord regarding a new lease. As well as a reduction in rent, we also negotiated a number of improvements to the site, some of which have now been completed. These negotiations have realised a saving in excess of 15 per cent per annum over the next 5 years. It should also be noted that we have also avoided any disruption to business and relocation costs.
