 - Several other countries have imposed restrictions on imports of poultry meat and poultry meat products sourced from New South Wales, with exports from other states unaffected. These countries include Hong Kong, Papua New Guinea, Singapore, the United States and the Solomon Islands.
- 2. Yes. Australian exports eggs and egg products and a range of inedible poultry derived products including rendered poultry and feather meals, poultry fats and oils, pet food and pharmaceutical/technical products.
- 3. Australia's key export markets for eggs and/or egg products affected by the occurrence of HPAI include Hong Kong, Papua New Guinea, Japan, Solomon Islands and Singapore. Australia's key affected export markets for inedible poultry products include China, Indonesia, Japan, Taiwan and the Republic of Korea.

4. The department is seeking to restore market access to affected markets as soon as possible and is regularly communicating with importing country authorities to minimise trade impacts. Some countries may lift restrictions once they have received further information and assurances regarding control and management of the situation. Others may not consider lifting restrictions until Australia has regained freedom from highly pathogenic avian influenza (HPAI) in accordance with the standards of the World Organisation for Animal Health (OIE), or until they have conducted their own assessments.

 - The department undertakes market access activities, including representations overseas, to support agricultural export industries, such as the kangaroo industry. Overseas representations by the department usually cover a range of commodities and market access issues, and may include kangaroo meat access if relevant to the country being engaged.
- 2. The kangaroo industry attended the Russia-Australia Agricultural Working Group in Sydney 2011 and a representative also accompanied the then Minister for Agriculture, Fisheries and Forestry Tony Burke to China in 2009. The department did not fund KIAA's involvement in these visits.

- 1. I've been previously advised in Senate Estimates that kangaroo meat for human consumption is not tested for food-borne pathogens like Salmonella spp or Toxoplasma gondii, both of which are zoonotic agents causing serious health risks in humans:
 - a) Are countries importing kangaroo meat informed of these health risks? Particularly with reference to Toxoplasma gondii which is rife in kangaroo populations?
 - b) Which countries importing kangaroo meat products request testing for these specific two zoonotic agents?
 - c) Does Russia request such testing for either T.gondii or Salmonella sp? Has Russia ever raised concerns about these agents or diseases?
 - d) Which importing countries have raised concerns about these zoonotic agents?
- 2. With regards to each category of kangaroo food products exported, may I have a list of which specific food safety tests each importing country requires?
- 3. With regards to food safety levels, please list the concerns or outcomes by each country in the last 10 years.
 - a) May I have details of all instances where any country's Maximum Residue Limits have been breached
- 4. What are the remaining barriers to opening up the trade for kangaroo products into China? What are the concerns raised?

- a) The department provides any information requested by importing countries to assist those countries in making assessments about health and other risks associated with our exports. Information regarding T. gondii would be provided if requested by an importing country.
 - b) No importing country authorities require pre-export testing for T. gondii or Salmonella.
 - c) Russia does not require pre-export testing for T. gondii or Salmonella. Russian authorities carry out routine testing for Salmonella on arrival to ensure compliance with its import requirements. Russia previously raised general concerns about the safety of kangaroo meat

which led to the suspension of kangaroo meat exports to that market in 2009. Russia has not raised any concerns with the department about T. gondii or Salmonella since trade resumed in November 2011.

- (d) A review of the department's records for the last two years indicate there has been one port-of-entry detection for Salmonella in kangaroo meat exported to the European Union, which occurred in March 2013. No other importing countries have raised concerns about Salmonella during the last two years. No importing countries have raised concerns about T. gondii in the past two years.
- 2. The department is unable to answer this question, as it would require an unreasonable diversion of resources to do so.

- 4. The department is working with Chinese authorities to finalise a small number of matters including minor amendments to the bilateral kangaroo meat protocol, agreement on health certification, and the specific approval of individual kangaroo meat establishments for export to China.

- 1. Where is the process of Chinese accreditation of Australian meatworks and cold stores up to?
- 2. How many facilities have been ticked off and how many are still seeking to get ticked off by the Chinese?
- 3. Chilled beef exports into China were suspended some time ago. What was the basis for the suspension? What action has been taken to correct the problems that caused the suspension and when will that trade resume if it has not already?

- 1. The approval process for establishments seeking to export meat and meat products to China includes approval by two separate Chinese government agencies. Following an audit carried out in 2010, four integrated slaughter establishments and 22 independent cold stores received approval from the first of these agencies in April 2012. They are currently awaiting final approval from the second Chinese agency, before they may commence exports to China. The department is working closely with Chinese counterparts to finalise this process.
- 2. Please refer to the response to question 1. All 26 establishment approved by one of two Chinese agencies following the 2010 audit are awaiting approval from the second Chinese agency before they are able to commence exports.
- 3. Establishments must be specifically approved by Chinese authorities to export chilled meat to China. The department is working with Chinese counterparts to complete the steps required for the approval of establishments. The Australian meat industry has temporarily stopped exports of chilled meat to China while establishments complete the approval process.
