**Mr Glyde:** That is a good question that I do not know the answer to. I would have to defer to my colleagues who are coming later on. They will be able to answer that question.

**Senator CAMERON:** If they are listening in. The other question that I would ask to give some thought to as well is: if there is a group of family farmers or a family farmer and an agribusiness, on the other hand, and they both make applications for a loan in the same regional area, who makes the assessment about who can get the loan? The family business may be less viable than the agribusiness in the longer term. I think we have canvassed something like this in estimates before. That is the fundamental question for the future of agriculture in this country.

**Mr Glyde:** The only thing I can add—and I certainly cannot answer the breadth of that question—is that the assessments are done by the rural adjustment authorities that are in each of the states and territories for which we have these loan arrangements. For example, in Queensland there is the Queensland Rural Adjustment Authority. They are the agents who follow the guidelines and make the decisions about who to loan to and for what. As I said, I do not know the specifics of the particular circumstance that you are talking about and I hope we will be in a position to answer that later on this afternoon.

#### Answer:

The Commonwealth is working with state and territory governments to establish loan conditions and delivery arrangements for the new drought concessional loans scheme from 2016–17. Final scheme arrangements are yet to be agreed.

- a. operates as a sole trader, trust, partnership or private company; and

- 4. The 2015–16 Drought Recovery Concessional Loans Scheme was offered to New South Wales, Victoria, Queensland, South Australia and Western Australia. The scheme is currently open for applications in New South Wales and Queensland. Victoria has chosen not to offer this scheme at this time.

#### Senator STERLE asked:

Is the Government planning on abolishing the National Rural Advisory Committee?

#### **Answer:**

As part of the Australian Government's Smaller Government – Towards a Sustainable Future reforms, which were announced in December 2014, the government chose to abolish the National Rural Advisory Council (NRAC) and merge its role into the Agricultural Industry Advisory Council.

Positions of the NRAC members were allowed to lapse or were revoked on 30 June 2015.

The Rural Adjustment Act 1992, which underpins the formation and operation of NRAC is scheduled to be repealed in its entirety as part of the Omnibus Repeal Day (Spring 2015) Bill 2015. The Bill, introduced on 12 May 2015, is currently before the House of Representatives.

The Agricultural Industry Advisory Council (AIAC) provides the Minister for Agriculture and Water Resources with information, advice and recommendations from a cross-section of industries and stakeholders, on the key issues affecting Australian agriculture.

#### Senator STERLE asked:

- 1. What work has commenced on advice and assistance from the Australian Taxation Office to taxpayers in drought-affected communities? White Paper claims that "the ATO will work with the Department of Agriculture to identify taxpayers.
- 2. How will the Department work with the ATO to identify drought affected farmers?
- 3. What privacy considerations will be undertaken so that information is kept confidential?
- 4. Has the Department undertaken consultation with drought-affected farmers regarding this measure?

#### Answer:

1. On 24 June 2015, the Australian Taxation Office (ATO) launched a dedicated hotline (Option 3 on 13 11 42) for drought-affected taxpayers and, as at 31 October 2015, had received over 9 000 calls to the hotline.

The ATO has commenced communication activities, initially using social media, aimed at promoting awareness of its available assistance and encouraging drought-affected taxpayers needing help to contact them on the hotline.

The ATO is currently developing letters that will be sent to businesses and individual taxpayers in drought-affected areas who are potentially experiencing difficulties fulfilling their tax obligations. The ATO expects to start issuing these letters before the end of 2015.

The ATO is planning to visit drought-affected areas in collaboration with other government agencies and non-government agencies where possible.

- 2. The department is assisting the ATO in identifying drought-affected areas.
- 3. The ATO has advised that it will protect the privacy of taxpayers in drought-affected areas in the same way that it protects the privacy of all taxpayers.

4. The department worked with the Department of the Prime Minister and Cabinet—the lead agency for the development of the Agricultural Competitiveness White Paper—throughout the White Paper consultation process. This process included over 1 100 discussions with farmers, individuals working in the supply chain, exporters and others, in rural, regional and metropolitan areas, as well as over 1 000 submissions. The ATO measure was developed in response to the issues and concerns raised during this consultation process.
