- Why was the departments key performance indictor for improving cost-recovery only partially met
- When will the government finalise its consideration of Import Risk analysis review's recommendations for improvement to parts of the IRA process?
- Provide detail as to who was consulted during the consultation phase of the cost recovery review.

Answer:

The final biosecurity, food, plant and live animal export Cost Recovery Implementation Statements (CRISs) were approved by the Minister for Agriculture and Water Resources, the Hon. Barnaby Joyce MP on 30 September 2015 and the Minister for Finance, Senator the Hon. Mathias Cormann on 30 October 2015. The CRISs were released publically on 30 October 2015 and are available at www.agriculture.gov.au/costrecoveryreview. The redesigned fees and charges will commence on 1 December 2015.

The Department of Agriculture and Water Resources (the department) has applied a cost modelling methodology that is consistent across all cost recovery arrangements. The redesign has simplified the structure to allow transparency in reporting and invoicing. The department's cost model clearly shows the fee and levy structure and their components. The modelling has been explained in each CRIS and quantified by the costs for each element of the fees and levies.

Once the new arrangements begin, quarterly reporting of cost recovery performance will continue to be provided to relevant industry consultative committees.

From October 2014 to August 2015, the department consulted on the redesign through established departmental industry consultative committees, industry forums, public forums, the department's website and industry notices. A special cost recovery inbox and hotline number were also made available.

There are no further consultations on the redesign as it is now complete. However, the department is continuing to consult with industry and clients on the implementation of the new arrangements. Regular engagement with industry consultative committees on business-as-usual cost recovery issues will continue, in line with established department practice.

The redesigned cost recovery arrangements come into effect on 1 December 2015.

The key performance indicator was only partially met because the redesign of the cost recovery arrangements had not been finalised by July 2015.

The department released the Examination of the Import Risk Analysis Process Report in July 2015. This report is available at: www.agriculture.gov.au/iraexamination.

The Import Risk Analysis Examination recommendations have directly shaped the development of the draft Biosecurity Import Risk Analysis (BIRA) Regulation and guidelines. Consultation on the BIRA Regulation and guidelines will close on 16 December 2015. These will come into effect as part of the implementation of the *Biosecurity Act 2015* on 16 June 2016.

Throughout July and August 2015, engagement sessions on proposed changes to cost recovery arrangements were held in Sydney, Melbourne, Perth, Adelaide, Hobart and Brisbane. A horticulture exports specific session was held in Mildura. Stakeholders were also provided with the opportunity to make submissions on the draft CRISs.

A wide range of stakeholders participated in the consultation process, including in the engagement sessions or by making submissions. The stakeholders included: large importers, horticulture growers and pack houses, customs brokers, universities, seed importers and exporters, honey bee importers, transport logistics companies, operators of Quarantine Approved Premises, fruit growers, aquaculture industry participants, grain exporters, companion animal transporters, pastoralists and graziers, pet food industry participants, winemakers, airline industry and live animal exporters.
