- 1. In 2013 I asked how there is no conflict of interest in the KIAA awarding its own CEO and international spokesperson (John Kelly) over \$800,000 worth of contracts.
- 2. The RIRDC advised that the KIAA "plays no role in the recommendation or selection of research projects."
 - a. Does the RIRDC still advise the KIAA "plays no role in the recommendation or selection of research projects"?
 - b. Is it still the case that the KIAA chooses the Chair of the RIRDC Kangaroo Industry Advisory Council (KIAC), which recommends the contracts the RIRDC should select for funding - as described in the KIAA's (then) 2013 Draft Kangaroo Industry Statutory R&D Levy Proposal?
 - c. Is it still the case that the Advisory Council usually meets once a year "in conjunction with the KIAA AGM, to assess full applications and recommend on project funding"? Again as described in the proposal?
 - *i.* Please provide details on the years the KIAC has had its annual meeting in conjunction with the KIAA AGM.
 - d. Is it still the case that the KIAA's own annual membership levy is forwarded to the RIRDC to attract commensurate government funding for RIRDC projects?
 - e. The KIAC was to include a representative from each of the 3 major sectors of the commercial kangaroo industry, the RIRDC Manager for the New Animal Products Program (under which kangaroos sit) and one further industry representative from any sector.

- *i.* Please advise how many of the commercial kangaroo industry representatives on the KIAC are *not* members of the KIAA.
- *ii.* Please advise how many previous members of the KIAC have not been members of the KIAA.

In June this year I lodged a Senate Motion ordering that the RIRDC market research report about messaging to different audiences, *Characterising the Australian public and communicating about kangaroo management* (Project ID: PRJ-008967).

Whilst I am aware that RIRDC research agreements state that the RIRDC may choose to "not publish" any report as it chooses, I am reliably informed it was the Kangaroo Industry Association of Australia (the KIAA) who refused to publically release the report.

Please explain how the KIAA, which represents private business, can refuse to publically release a publically funded report which is about growing an industry that profits out of the shooting of native wildlife?

- 2. May I please have a list of all RIRDC kangaroo associated reports or projects that have been contracted to (Dr) Rosie Cooney, or where Rosie Cooney has been an author or associate with the project: Please include the aim and cost of each project.
- 3. Are there any current or planned projects that are part of an effort to lift California's ban on the importation of kangaroo products? May I please have the researcher details, Objectives and cost?
- 4. The RIRDC report, "Characterising the Australian public and communicating about kangaroo management" sits in the R&D priority of "Reinforcing the license to operate". Its research details as listed on the RIRDC website says it aims to "provide practical information on how to design specific communications relating to the management of kangaroos".

The example given is that the kangaroo industry provides targeted messaging and, I emphasise, "a government environmental/conservation agency could present information on a specific culling program in order to gain more public acceptance".

Social license market research is about how to manipulate information to targeted decision-makers to accept your product or actions, and grow your market:

a. Please explain how the manipulation of information ("how to design specific communications") to ensure government environmental agencies, or NGO conservation agencies become industry messengers "to gain more public acceptance" for shooting kangaroos, is an exercise in transparency and independent advice?

KIAA CEO Conflicts of interest funding

- 1. In February 2013 Senate Estimates I was advised that from 2000 to 2011, the RIRDC had awarded \$800,312 worth of contracts to John Kelly, CEO of the Kangaroo Industry Association of Australia and owner of the commercial wallaby meat, fur and skins processor and exporter Lenah Game Meats, for 11 RIRDC reports to grow the sales of products made from commercially shot kangaroos. I note also Mr Kelly currently has an application with the Department of Environment to export up to 60,000 Bennett's wallaby skins per year.
 - a. How many RIRDC kangaroo projects have been awarded to Lenah Consulting or John Kelly since 2010:? If any:
 - i. what was/is the aim of each project
 - ii. what was the value of funding/cost?
 - b. The RIRDC funded Mr Kelly \$236,664 for "Research to assist market development for kangaroo products in California & New York" from 2008 to 2011. This included Kelly's report "California, New York, the World and Kangaroos".
 - c. Please provide a detailed breakdown of how that \$236,664 was spent.

- a. There have been no projects awarded to Lenah Consulting or John Kelly since 2010.
- b. No comment.
- c. Project funds were spent consistent with the project contract. The majority of the funds (\$206 584) were used by the project provider to engage a firm of US consultants. The consultants were engaged to develop and implement a process to inform Californian and New York legislators in 2009 and 2010 as to the regulation and sustainability of the kangaroo industry, from materials made available by the provider. The remainder of the funds were used by the provider to collate the materials and manage the consultants.

Answer:

- 1. Rural Industries Research and Development Corporation (RIRDC) was contracted by the Department of Agriculture and Water Resources to undertake design and scoping work for the Co-operatives and Innovative Business Models two year pilot program.
- 2. RIRDC has received \$200 000 (GST not applicable) for the design and scoping project.
- 3. RIRDC has spent or committed the full \$200 000 received.
- RIRDC has provided a report, including a draft program framework, for the consideration of the Department and the Minister for Agriculture and Water Resources. RIRDC provided its report to the Department on 23 October 2015.
- 5. Final decisions on the scope and nature of the program have not yet been made.
