## Senator Waters asked:

Senator WATERS: ...Can you provide an estimate of how many versions the State of the environment report went through?

Dr Grimes: We may well have to take that on notice. I will to see if any officers here have that information to hand. We would have to take that on notice. I suspect it may be difficult for us to answer because segments of the report tend to be done as individual chapters before the report itself gets brought together.

Senator WATERS: Sure. If you need to take that on a chapter-by-chapter basis, that would be fine, too.

Dr Grimes: We can take that on notice and see what information we may be able to provide to you.

Senator WATERS: I am interested also in how many of those versions incorporated feedback or comments from the minister's office?

Dr Grimes: We will be able to take that on notice and see if there is anything we can provide you at all.

# Answer:

## Early versions of the report

There were multiple authors working on different chapters during the process of producing the National State of the Environment report for 2011. The drafting of each chapter was a collaborative and iterative process involving many consultations and contributions. Independent committee members were responsible for leading the drafting process for one or more chapters.

There were three key versions of each of the theme chapters. These versions relate to three major stages in the production process prior to compiling the final report.

- Versions submitted to independent peer review (May to July 2011). The process of peer review and the results are publicly available. See <u>http://www.environment.gov.au/soe/2011/supplementary/pubs/soe2011-supplementarypeer-review-of-the-australia-state-of-the-environment-2011-report.pdf.</u>
- Versions, post peer review, circulated for final accuracy and fact checking by contributors (July to August 2011).
- Versions submitted to copyediting/proofreading/design (August to November 2011).

# Individual chapters

The three stages above apply to ten chapters: Drivers, Atmosphere, Inland water, Land, Marine environment, Antarctic environment, Biodiversity, Heritage, Built Environment, and Coasts. The remaining chapters – Summary, Approaches and Future Reporting - did not undergo external peer review or fact checking by external data providers.

There were no comments or feedback from the Minister or Minister's Office on any drafts.

Dr Grimes: I personally cannot tell you the point at which it was drafted, but the officers here may be able to assist you.

# Answer:

The recently released report titled Australia State of the Environment 2011 contains a chapter called 'Summary'.

The 'Summary' was authored by the independent State of Environment 2011 Committee. See http://www.environment.gov.au/soe/2011/pubs/committee-2011.pdf for composition of the committee.

An introduction to the Summary chapter was developed by the chairman of the committee and circulated to other authors, in April 2011, for input on each specific reporting theme. During the period April-July, authors collaborated on the draft Summary chapter while they were also developing the theme chapters.

Once the theme chapters of the report were finalised in October, the Summary chapter was updated accordingly and then went through final copy-editing, proof-reading, design and clearances by authors in the lead up to finalising the report for printing.

# Senator Fisher asked:

1. Please provide copies of correspondence between either the Department of Sustainability, Environment, Water, Population and Communities or the Department of the Environment, Water, Heritage and the Arts and the Department of Climate Change and Energy Efficiency and regarding the Renewable Energy atlas.

2. Does WindLab provide data on wind speed and direction free of charge?

3. How many complaints has the department received about the removal of the Atlas?

## Answer:

- There was no formal correspondence between the above mentioned departments on the Renewable Energy Atlas. However, six emails were exchanged between the Department of Sustainability, Environment, Water, Population and Communities and the Department of Climate Change and Energy Efficiency regarding the Atlas.

## Senator McKenzie asked:

- 1. What funding from the \$100m Suburban Jobs program announced at the last budget has been allocated to Victorian cities?
- 2. What sort of projects have been funded so far?
- 3. What is the process for accessing the funding?

#### Answer:

- 1. Grant funding under the (now) \$45 million Suburban Jobs program will be allocated to a small number of large, integrated projects following a competitive grant round.
- 2. Projects have not yet been funded as the successful applications for the Suburban Jobs Program have not yet been announced.
- 3. Applications closed on 17 February 2012. Applications received will be assessed against the eligibility and selection criteria outlined in the Suburban Jobs Program Guidelines (available online at www.environment.gov.au/sustainability/suburbanjobs). The announcement of successful applications is expected to occur in the first half of 2012.
