Senator Ludwig asked:

Update the status of each grant that was approved prior to 7 September 2013, but did not have financial contracts in place on 7 September 2013. Provide details of the recipients, the amount, the intended use of the grants, what locations have benefited from the grants and the electorate and state of those grants.

Answer:

The table below provides an update to the status of the previous reported grants question on notice.

Please note that whilst the previous response to Question 129 of 27 November 2013, indicated that "as at the time of reporting, no decision had been taken to cancel, pause, discontinue, or cut... any of the grants" a further review of Departmental records has revealed that some of the grants listed had been subject to a decision by Government on 9 October 2013 to be discontinued. These grants were part of the Biodiversity Fund and Caring for Our Country programs. These grants are included in the table below and identified as not progressing to contract, as they were deemed inconsistent with the new Government's policy position.
