#### Answer:

# **Department of the Environment:**

In order to ensure alignment of the role and responsibilities of the Department with government priorities and the reductions in available funding, the Department has undertaken an internal strategic review. This review has identified an overall reduction in staffing levels over the forward estimates period. The Department has instigated a voluntary redundancy program and is targeting 250 redundancies. Staffing levels beyond this current redundancy program will be considered in the context of the outcomes of the 2014-15 Budget.

- a) The Department manages its budget holistically and in accordance with the government's priorities, as such any staffing reductions are not allocated to individual budget measures.
- b) As stated above the Department does not directly attribute reductions in staffing levels to specific budget measures. Funding reductions are comprised of the sum of budget and savings measures from all previous Budget decisions.
