Senator Ludwig asked:

How many documents (include the amount of copies) have been printed from Supplementary Budget Estimates in November 2013 to date? How many of these printed documents were also published online?

Answer:

The Department (including the Australian Antarctic Division)

For the purpose of this response, a 'document' is defined as a book, booklet, brochure, guide, flyer, or factsheet.

Sixteen documents have been printed since the Supplementary Budget Estimates in November 2013 to 24 February 2014, with print quantities ranging from 100 to 4,000. Nine of the 16 documents had a printing quantity of 500 or less.

The Department uses a print management system to manage Panel and Multi-User List arrangements which tracks and reports all communication product activity including the volume of print material produced.

All of the Department's public documents are published online, excluding stationery items such as business cards or promotional materials such as banners.

The Department (Darwin/Jabiru):

Two documents have been printed since the Supplementary Budget Estimates in November 2013 to 24 February 2014, with print quantities of 80 and 500.

Both of these documents have been published online.

Bureau of Meteorology

Ten documents (with a total of 2,170 copies) have been printed since the Supplementary Budget Estimates in November 2013 to 24 February 2014.

Nine of these documents were also published online.

Clean Energy Regulator

Nine documents (with a total of 2,750 copies) have been printed since the Supplementary Budget Estimates in November 2013 to 24 February 2014.

Six of these documents were also published online.

Climate Change Authority

One document has been printed since the Supplementary Budget Estimates in November 2013 to 24 February 2014, with a print quantity of 100.

This document was published online.

Director of National Parks

Two documents have been printed since the Supplementary Budget Estimates in November 2013 to 24 February 2014; one had a print quantity of 10, the other 20,000. Both documents were published online.

Great Barrier Reef Marine Park Authority

Four documents have been printed since the Supplementary Budget Estimates in November 2013 to 24 February 2014, with quantities ranging from 100 to 68,700.

All of these documents have been published online.

Murray-Darling Basin Authority

Two documents have been printed since the Supplementary Budget Estimates in November 2013 to 24 February 2014, with quantities of 600 and 1,000.

Both of these documents have been published online.

National Water Commission

No products were printed during the reporting period.

Sydney Harbour Federation Trust
