6. The World Heritage Committee is an expert decision making body. The Department's experts in heritage matters and the World Heritage Convention maintain ongoing formal and informal communication with the Committee, the World Heritage Centre and advisory bodies to the Committee. Ongoing contact ensures that the Department is able to present the progress Australia is making against the Committee's recommendations and to understand any emerging Committee deliberations. The Department's interactions with the Committee, Centre staff and advisory body representatives are both prudent and efficient. The Department minimises costs by scheduling appropriate meetings with Committee members, the Centre and/or advisory bodies in the margins of other international fora on other topics. As a result of this approach, separate meetings cannot be specified as they are often part of other international engagement designed to meet other government objectives.
