Following discussions with our construction partner Ergon Energy it became evident that the redirection of resource effort required by Ergon to repair its own network would mean estimated delays of up to eight weeks in the final completion date for Townsville, and Armidale became the first site on the mainland to be completed.

NBN Co is putting cables underground wherever useable existing ducting is located.

The effect on total funding (levered) would be an extra \$1.2 billion in total funding and \$1.7 billion additional requirement in Government equity. In addition to the impact of cherry picking in Greenfields, there would be an impact in the most commercially attractive areas of Brownfields. This would take the returns well below 5%.

a-c NBN Co is currently undertaking a trial of the fibre optic network extension process with selected properties that border the Tasmanian second release sites of Triabunna, Sorell, Deloraine, St Helens and South Hobart.

This trial is designed to establish a process for dealing with requests from end-users, businesses or governments to extend the fibre or wireless footprint beyond the planned rollout of the National Broadband Network.

NBN Co will establish objective design criteria which will be used to define the footprints of each access technology. These design criteria become the starting point for considering Network Extension propositions.

An application process will need to be established for end-users to make requests for Network Extensions. NBN Co will be charging end-users the incremental cost of installing infrastructure beyond the footprint produced by applying the design criteria.

As part of this trial, NBN Co will determine how much the extension will cost for a particular property. If the property owner chooses to go ahead with the network extension, they must pay the relevant amount to NBN Co.

NBN Co uses the same definition of community as used by the Australian Bureau of Statistics in its census data. Communities are commonly thought of as being groups of people living within particular geographic areas. However, there are other connections between people which are not geographically based but which indicate the existence of communities. NBN Co uses the geographical definition.

The number of communities with less than 500 premises that are passed by the NBN Co transit backhaul is not known precisely as much of this part of the network will, under the deal with Telstra, use their network and precise details of this are not available to NBN Co.

"Passed" as a definition has different meanings across our three products (fibre, satellite and wireless) so it is not easily defined. In the fibre serving areas it can best be described as "within close proximity" but without using a specified distance.

NBN Co's Corporate Plan released in December 2010 assumes no commercial agreement with Optus. It therefore reflects our assumptions on returns without an agreement with Optus. NBN Co's next Corporate Plan will take into account the Optus agreement, entered into by Optus on commercial grounds.

What would the impact on NBN Co's expected returns be if the Telstra HFC network was permitted to continue to operate in competition with the NBN in the provision of broadband services?

Answer:

NBN Co and Telstra have reached a commercial agreement for the progressive disconnection of Telstra's fixed line traffic in relevant areas (excluding HFC Pay TV traffic). In evaluating the benefits of this commercial arrangement, NBN Co did not separately calculate the effect of treating Telstra's non-Pay TV HFC traffic differently as both parties were seeking an integrated outcome.

Answer:

NBN Co has made no such calculation as it is inconsistent with the Statement of Expectations it has been given by its shareholders to build a network providing fibre access to 93% of Australian premises and 7 percent fixed wireless and satellite.
