Mr Branson: We might have to take on notice the question of the number of cancelled STCs.

Answer:

By way of clarification, the legislation does not provide for Small-scale Technology Certificates (STCs), once created, to be cancelled. When STCs have been created, they can only be removed from the market through a surrender process.

The following response is made in the context of 'compliance', referring to monitoring and enforcement activity undertaken to mitigate the risks identified through the Risk Management Framework of the Office of the Renewable Energy Regulator (ORER).

The ORER monitors the creation of certificates and will, in accordance with the Risk Management Framework, prevent the creation of STCs where the requirements for the creation of STCs have not been met.

When it is identified that STCs have been improperly created, in circumstances other than administrative error, action is taken to have the creator surrender an equal number of certificates. In some cases the creator, once the issues are brought to their attention, will surrender the required number of certificates without further action by the ORER.

In other instances, the authorities of the Regulator, such as Enforceable Undertakings, are utilised.

The number of STCs surrendered for compliance purposes for the year to date is 27,997. This figure is made up of 23,449 Large-scale Generation Certificates (for small generation units installed prior to 1 January 2011) and 4,548 STCs.

The Office of the Renewable Energy Regulator (ORER) commenced inspections of solar photovoltaic systems in May 2011, undertaking inspections under Part 7 of the *Renewable Energy (Electricity) Regulations 2001*. The inspections check that installations meet the legislated requirements for the creation of Small-scale Technology Certificates (STCs). This includes checking if the solar panels installed meet applicable Australian standards, state and territory requirements and industry guidelines.
- 2. By the end of 2011, 2,800 inspections will be completed across Australia in New South Wales, Victoria, Queensland, Adelaide, Western Australia, Northern Territory, Tasmania and the Australian Capital Territory.

- 3. Not applicable.
- 4. ORER has publicly released initial inspection results. These are available at: <u>www.orer.gov.au/Solar-Panels/Inspections/inspections</u>.
- 5. Initial results have identified that the majority of issues relate to DC isolators and their enclosures. However, it is early in the program implementation and the number of inspections completed to date is insufficient to draw firm conclusions. As further information becomes available, analysis of the data will provide a clearer picture of any patterns in faults and enable better targeting of non-compliance.
- 6. The ORER has no particular reason to be concerned about the quality of imported panels.
- 7. Under the *Renewable Energy (Electricity) Act 2000*, for a solar photovoltaic system to be eligible for the creation of STCs, the system must be designed and installed in accordance with the relevant Australian Standards and the Clean Energy Council (CEC) guidelines. The CEC design guidelines specify the designer of the system must estimate the available solar irradiation for the array based on the Australian Solar Radiation Data Handbook. The calculation takes into account the tilt, orientation and the effect of any shadows. This estimate must be provided in the quotation to the customer.
- 8. Under the *Renewable Energy (Electricity) Act 2000*, eligibility for STCs from solar photovoltaic systems is based on the deemed amount of electricity generated by solar photovoltaic systems. The deeming calculation used by ORER is not based on the maximum output but on average amount of electricity generated. The STC eligibility for solar photovoltaic systems is generally equivalent to one megawatt hour of renewable electricity deemed to be generated by small generation units (unless the Solar Credits multiplier applies).

Answer:

Yes. The role of the Office of the Renewable Energy Regulator (ORER), with regard to the installation of solar panels, centres on the proper creation of certificates. For a solar installation to be eligible for certificates, it must satisfy the conditions prescribed in the *Renewable Energy (Electricity) Regulations 2001*. The Regulations require that the installation complies with all relevant Australian standards and applicable state and territory legislation.

Allegations of breaches of the *Renewable Energy (Electricity) Act 2000* or the *Renewable Energy (Electricity) Regulations 2001* are referred to the ORER compliance team and dealt with in accordance with ORER's Compliance and Enforcement policy.

Allegations are received from a number of sources including:

- the Clean Energy Council (CEC);
- members of the public;
- solar industry members;
- ORER's inspection function; and
- other ORER functional areas that monitor compliance with the Act.

The ORER has a range of options for dealing with potential breaches. These range from encouraging voluntary rectification of any issues identified through to taking civil or criminal prosecution action.

Where safety issues are identified during an ORER inspection of a solar installation, the relevant state or territory regulatory authority is advised of the issue. The states and territories have the responsibility for dealing with safety issues.

The ORER is unable to provide a response about the increased cost to infrastructure as a result of the large number of PV systems currently being installed with the distribution networks. However, the Department of Resources, Energy and Tourism would be in a better position to provide a response.

Network service providers are required under the National Electricity Rules to maintain standards for voltage, frequency and network loading under changing electricity demand and generation from embedded solar PV panels. Organisations such as the Australian Energy Market Operator, Australian Energy Regulator and Australian Energy Market Commission will also be in a better position to provide information about network related issues.

Answer:

The Office of the Renewable Energy Regulator's (ORER'S) role in respect to this matter is to ensure that only eligible Renewable Energy Certificates enter the market. As far as the ORER is aware, Well Being Green has not breached the *Renewable Energy (Electricity) Act 2000* (the Act) or the associated Regulations by creating ineligible certificates. The business practices and/or payment arrangements of Well Being Green are not matters covered by the Act.

The ORER does not keep records of matters unrelated to its statutory responsibilities. The ORER is not able to say with certainty when or how many times matters related to the business practices and/or payment arrangements of Well Being Green have been raised with ORER staff.

When matters of this kind are raised it is usual Office practice to recommend to anyone with a concern about the business practices and/or payment arrangements of a company to contact the Australian Competition and Consumer Commission, the Australian Securities and Investments Commission or the relevant state/territory fair trading office as appropriate. The ORER may also pass on information to these agencies to the extent permitted by the Act.

The ORER does not maintain records about companies that have gone into liquidation owing businesses money.
