For the period 1 July 2011 to 30 June 2012 the Department of Sustainability, Environment, Water, Population and Communities (the department) has been charged \$1,308,353 (GST inclusive) for electricity. This includes 8,053,920.20 kWh of metered electricity plus a small amount charged on a per square metre of space basis which was not on a separate meter. This amount does not include the cost of generating electricity in the Antarctic Bases as this cannot be determined.
 - a. The average cost per full time equivalent employee (FTE) is \$500.50 based on an FTE of 2,614.1.
 - b. The department's energy provider for Canberra have advised that the department will be charged an additional \$0.02 per Kilowatt due to the carbon tax.

- c. Due to initiatives that have provided savings in consumption and cost of electricity, to date there has been no net impact on the department due to the carbon tax.
- d. Not applicable.
- 2. Whilst data for the whole department for this financial year to date is not yet available, the department's offices in Canberra have reduced electricity consumption for the period July to September by 11 per cent over the same period in the 2011/2012 financial year. This is a result of ongoing strategies to minimise energy consumption.
 - a. The department has an ongoing commitment to reduce its greenhouse gas emissions. The introduction of the carbon tax has not changed this commitment.
 - b. The department has implemented a number of measures to reduce its electrical expenditure. These include the introduction of more efficient printing and desktop information technology solutions and the upgrade of the lighting system in one of its major tenancies in Canberra. The information technology solution was fully implemented by March 2012 and has yielded a 14 per cent saving in tenant light and power to the department in the 2011/2012 financial year. The lighting upgrade reached practical completion in May 2012 and is showing a 34 per cent decrease in electrical consumption to date.
