NEW BOARD FOR ELITE MUSIC PROGRAM

A group of leading arts advocates and music educators have been appointed to the Australian National Academy of Music (ANAM) Board to develop an enhanced training program that better meets the needs of the classical music sector.

Arts Minister Peter Garrett and University of Melbourne Vice-Chancellor Professor Glyn Davis congratulated appointees to the new Board.

"This is an exciting time for ANAM as it puts in place an improved program that builds on its past achievements," Mr Garrett said.

"This new Board is responsible for working to provide elite music students with a national professional performance program that includes a broad range of instruments, and provides internships and mentoring opportunities with professional orchestras.

"Students will be able to access flexible training that equips them to perform a variety of orchestral roles. They can also undertake accredited and non-accredited training that is individually tailored to meet their needs.

"I am delighted that Ian McRae has agreed to Chair the Board. He brings a wealth of experience to ANAM and has the leadership skills to guide the organisation through this important period."

Mr McRae is currently Chair of the Australian Ballet School and a Director of Melbourne Recital Centre, Malthouse Theatre and Bangarra Dance Theatre. He has many years of experience on arts boards, including the Australia Council, Bell Shakespeare Company and the Victorian College of the Arts.

"I am excited about working with the Government, the University and the ANAM Board and staff to enhance the development of ANAM's training program and its essential relationships with the music sector across Australia," Mr McRae said.

Five Board members have been appointed and the remaining two vacancies will be nominated by the Board when it first convenes. ANAM is a subsidiary company of the University and is managed by an independent board.

Professor Davis said the new Board has a good mix of education, music and governance expertise.

"With the previously announced international advisory panel, ANAM now has a broad range of expertise at hand as it works towards providing the best possible training to equip our most talented classical musicians for careers as professional performing artists," Professor Davis said.

Other Board members include: Professor Warren Bebbington, Pro Vice-Chancellor (Global Relations) and former Dean of Music, University of Melbourne; Ms Penny Hutchinson, Director, Arts Victoria; Professor Barry Sheehan, Chair, University of Melbourne's 'New Music Conservatorium Steering Group'; and Mr Shane Simpson, Simpsons Solicitors and Chair of 'The Song Company'.

Senator BIRMINGHAM —...I understand this is a program funded, as I said, through the federal Regional Arts Fund, operating in Bunbury. As I said, it is called Disability in the Arts, Disadvantage in the Arts and it supports 150 disabled people in their activities.

The program is funded until the end of 2008, as I am advised, and they are awaiting some funding decisions from government. Are you aware of this issue at all?

Ms Bean— I am not aware of that specific project. I will just check to see if we know where it is at. ... Certainly if there is a problem I would be happy to talk to Country Arts WA to sort it out.

Senator BIRMINGHAM— Perhaps you could take it on notice to look into the program to which I have referred to see whether there is ongoing funding support for it and, if so, how much and over what time frame, in general. The Regional Arts Fund, as you said, is administered locally by local arts bodies. Is there a specific component of that that is dedicated to supporting disability ventures?

Ms Bean— Not specifically. I should say that the Regional Arts Fund is generally about project funding rather than organisational funding, so there must be some project element to it. Beyond that I do not know.

There is not a specific disability category or bucket but we certainly encourage the regional arts organisations to fund a wide diversity of projects and different types of groups.

Senator BIRMINGHAM—Perhaps you could take that on notice. Also, if perhaps they are seeking funding through the wrong area, maybe you could at least suggest alternate programs that might be available for such an organisation.

Ms Bean—Certainly; I will have a look into it.

Answers:

Regional Arts Fund (RAF) is a devolved program delivered by Regional Arts Organisations in each State and Arts Departments in NT & ACT.

Disability in the Arts, Disadvantage in the Arts applied to and received funding in a previous RAF funding round. Country Arts WA (CAWA) has confirmed that the organisation has applied for further funding in the next RAF funding round which closed mid March 2009. CAWA anticipates the outcome of this round to be known by May 2009.

Senator BIRMINGHAM—If you could confirm the last year in which they will receive that additional funding that would be appreciated.

In 2006-07 the Australian Government committed to provide the Australian Youth Orchestra with an additional \$1.88 million over four years for the purpose of strengthening its programs, reserves and triennial international touring program. This funding is due to terminate after 2009-10.

 - o deliver accredited and non-accredited modules as part of the enhanced program.
 - build relationships between ANAM and professional orchestras, including the development of professional placements to augment training for key orchestral roles;
 - o establish and convene an Academic/Artistic Advisory Committee;
 - o develop a staff structure for delivery of the enhanced ANAM program, including duty statements;

- devise a recruitment strategy for a full time General Manager and for an Artistic Director with demonstrated artistic and professional experience who can strengthen ANAM's engagement with the classical music sector both nationally and internationally;

- o build ANAM's national profile, including ensuring a national audition process and developing a working alumni database which records the professional progress of alumni.
- 4. Additional funding was not offered to the University of Melbourne. On 28 November, the Minister announced additional funding to ANAM of \$500,000 to boost performance training during the transition to the enhanced ANAM program. The additional \$500,000 is included in ANAM's funding allocation of \$1.518 million to 30 June 2009.
