- 1. Parks Australia regularly reviews how to more effectively manage the climb and reduce visitor safety risks. New (reduced) December to February summer opening hours were introduced in 2007 after consultation with tourism industry representatives. The new opening hours commenced on 1 January 2008. During January and February the climb was open from 5:30am to 8:00am each day (weather permitting), and closed for the rest of the day when the heat, wind and rain usually makes the climb unsafe. Since 2003, the climb has been closed because of weather conditions for more than 80 percent of summer daylight hours last year it was only open after 08:00am for two days in December, four days in January, and not at all in February. There have been no other changes to hours (or costs) in the last 12 months.
- 2. There are no plans to alter costs for access to Uluru-Kata Tjuta National Park. Conditions for access to Uluru will continue to be set out in the Management Plan for the Park. The Board of Management is expected to release the draft of the next plan early next year for public comment.

- 2. The tourism campaign promoting Kakadu is managed and largely funded by Tourism NT. The Australian Government contributed \$0.5 million in 2006-07 towards this campaign.
- 3. Refer response to part (2) above.
- 4. The success of the Tourism NT's campaign is a matter primarily for the NT Government. Success will be monitored and measured in several ways including: feedback from the tourism industry, the Northern Territory Government and the Kakadu Board of Management; the success of new indigenous businesses in the Park; and the results from a new visitor survey introduced this year. Visitor numbers to the Park have increased over recent years and a number of new Indigenous businesses have established in the Park.
