#### **Senator Eggleston asked:**

Are you able to tell the committee about resale royalty schemes that exist in other countries; what their structure is, how long the royalties are paid to artists and their descendants for?

#### **Answer:**

54 countries out of 164 contracting parties to the Berne Convention for the Protection of Literary and Artistic Works ('the Berne Convention') have introduced a resale royalty right, including the United Kingdom and other European Union member states.

The parameters and effectiveness of these schemes differ quite markedly, depending on the model and the administration arrangements for the scheme. Some international examples are provided in Table A, which formed an attachment to the 2004 *Proposed Resale Royalty Arrangement Discussion Paper* prepared by the former Department of Communications, Information Technology and the Arts.
