An invitation was extended by General Motors whereby it would work with Australian suppliers on a 'road mapping' exercise. Ford has committed to working with Australian component manufacturers to address shortcomings and to help identify supply opportunities within the region including in Thailand, where Ford has manufacturing facilities and which has a bilateral free trade agreement with Australia.

Senator Campbell asked:

- (a) Can the Department confirm that an invitation was extended for parts makers to return to Detroit later this year?
- (b) When is this anticipated to occur?
- (c) What are the objectives of this return meeting?

ANSWER

- (a) An invitation was extended by both Ford and GM to work with Australian suppliers on a 'road-mapping' exercise. In addition, Ford and GM have agreed to a further visit by component manufacturers to Detroit, as announced by Minister Macfarlane on 13 February 2006.
- (b) This visit is expected to take place in the second half of 2006.
- (c) The objective of this meeting is to assist Australian component producers to identify opportunities for greater involvement in both Ford and GMs' global supply chains.
