What is the cost of the "additional analysis and research on the Premises Standard" and what budget item does it come under in the ABCB budget?

ANSWER

The cost of the additional analysis is expected to be \$130,046.

The work is being funded from the ABCB 2005-06 budget provision for its Regulation Impact Statement (RIS) activities.

Who is undertaking this "additional analysis and research on the Premises Standard", including the name(s) of members of the project team(s)?

ANSWER

The additional analysis was undertaken by Jaguar Consulting Pty Ltd in consultation with the Turner & Townsend Rawlinsons and ABCB office staff. A peer review of the draft RIS was undertaken by Access Economics Pty Ltd.

ANSWER

There are seven documents that set out the brief for the additional analysis and research.
