Senator LUDWIG asked:

With regard to all grants allocated by the department/agency from 1 January 2002, could a table detailing the following information be provided:

- a. The name of the grant program
- b. The name of the grant recipient
- c. The ABN of the grant recipient (where available)
- d. The amount awarded
- e. The date the grant was awarded
- f. The state of the grant recipient
- g. The postcode of the grant recipient

Answer:

Since 1 January 2002 the AOFM has been responsible for allocating two government grants, in the form of specific purpose payments, to the States and Northern Territory. Details of each of the grants are provided in the following tables:

(i) Debt Redemption Assistance

Covers the payment of compensation to the States and Northern Territory under the *Financial Agreement Act 1994*, for the additional interest costs of replacing maturing Commonwealth debt with their own borrowings, rather than by the Commonwealth borrowing on their behalf, and for the lower, formula-based, Commonwealth sinking fund contributions which have resulted from the debt redemption arrangements. The final compensation payment to the States and Northern Territory was effected on 1 April 2006.
