- 16. The Department has granted 5 FOI requests since 3 December 2007 and denied 6.
- 17. No conclusive certificates have been issued in relation to FOI requests.
- 18. The Minister spent \$7,672.64 on travel and expenses for the Community Cabinet meetings held since Budget Estimates.
- 19. Seven Ministerial staff and eight Departmental officers have travelled with the Minister for the Community Cabinet meetings held since Budget Estimates.
- 20. The total cost of travel to Community Cabinet meetings was \$29,869.03.
- 21. The Department spent \$12,513.83 on travel and expenses for the Community Cabinet Meetings held since Budget Estimates. The Minister's Office spent \$17,355.20 on travel and expenses for the Community Cabinet Meetings held since Budget Estimates.
- 22&23. Four Reviews are currently being undertaken in the portfolio/agency or affect the portfolio agency, including:
  - The Montara Commission of Inquiry (due to conclude in April 2010);

  - Energy Efficiency Opportunities Program mid-term review (to be completed by July 2010).
- 24&25. The following Reviews have been completed since Budget Estimates:
  - Review of the Trade Practices (Industry Codes Oilcode) Regulations 2006 (currently being considered by Government);
  - Petroleum Import Infrastructure in Australia (currently being considered by Government);
  - The Review of Regulatory Efficiency in Uranium Mining (currently being considered by Government);
  - Henry Tax Review (further timing is a matter for the Treasurer); and
  - Performance Audit of Geoscience Australia by the ANAO (Government response not applicable).
- 26&27. Since 3 December 2007 there have been 15 reviews (both completed and ongoing) in the Resources, Energy and Tourism portfolio, or affecting the portfolio, with an estimated cost of \$7,692,883.40.

28. The Resources, Energy and Tourism portfolio has no further reviews planned for the 2009-10 financial year.

### 29. Department of Resources, Energy and Tourism

Since 3 December 2007, the Department of Resources, Energy and Tourism has entered into 520 consultancy contracts involving actual expenditure of \$41.9 million.

In accordance with the Australian Government's Procurement Publishing Obligations for FMA agencies, consultancy services let by the Department of Resources, Energy and Tourism since 3 December 2007 of \$10,000 or more are listed at <u>Attachment C</u>.

#### Australian Solar Institute

The Australian Solar Institute has not entered into any consultancy contracts since its inception in July 2009.

#### Geoscience Australia

Since November 2007, Geoscience Australia has entered into 69 consultancy contracts involving actual expenditure of \$3.7 million.

In accordance with the Australian Government's Procurement Publishing Obligations for FMA agencies, consultancy services let by Geoscience Australia since November 2007 of \$10,000 or more are listed at Attachment C.

#### National Offshore Petroleum Safety Authority

Since November 2007, the National Offshore Petroleum Safety Authority has entered into 30 consultancy contracts involving actual expenditure of \$2.5 million.

In accordance with the Australian Government's Procurement Publishing Obligations for FMA agencies, consultancy services let by the National Offshore Petroleum Safety Authority since November 2007 of \$10,000 or more are listed at Attachment C.

#### Tourism Australia

Since November 2007, Tourism Australia has entered into 26 consultancy contracts involving actual expenditure of \$2.4 million.

In accordance with the Australian Government's Procurement Publishing Obligations for CAC Act bodies, consultancy services let by Tourism Australia since November 2007 of \$400,000 or more are listed at Attachment C.

- 30. There are 38 consultancies planned for this calendar year in the Resources, Energy and Tourism portfolio. Further details of each planned consultancy can be found at <u>Attachment D</u>.
- 31. The Sustainable Tourism Cooperative Research Centre (STCRC) is currently funded until the 30 June 2010. The Department is not undertaking any current research that has resulted from the decision not fund the STCRC past 30 June 2010. The Department is providing the Secretariat for the Research and Development Advisory Board establishment.
- 32. The Department is not producing or involved in the current production of the State Tourism Satellite Accounts. However, discussions are well advanced with the States and Territories for the Department to put in place new institutional arrangements to ensure the continuation of the production of State Tourism Satellite Accounts.
- 33. Neither the Department nor the Minister's office received any formal requests for the Tourism White Paper Evaluation Report. A copy of the Report is attached as part of the response to AR11.

34. This question was answered during the Estimates hearing on 11 February 2010 (ref: Proof Committee Hansard, pgE5). The relevant extract from the Hansard is provided below.

Senator EGGLESTON—The development of the National Long-Term Tourism Strategy to provide a strategic framework for engagement with the tourist industry: can you tell us how much funding will be allocated for each recommendation in the Long-Term Tourism Strategy?

Ms Madden—You will recall the minister launched the National Long-Term Tourism Strategy in Western Australia, in Perth, on 15 December. I believe you were there, Senator.

Senator EGGLESTON—Yes, that is right.

Ms Madden—As part of that overarching framework, a number of key working groups were established to scope and put forward work programs to deliver the achieved outcomes. Those working groups have been meeting since the release of the strategy. All of them are scoping the required budget and resources, and meetings will be held in coming weeks to take that forward in 2010-11 budget context.

Senator EGGLESTON—So you cannot give me specific figures about how much money will be allocated for each of the recommendations?

Mr Pierce—No, not at this point. You would appreciate that a lot of the work that is going to be undertaken is not just being undertaken by the Commonwealth. It is a key part of the process to bind the states and the Commonwealth—

Ms Madden—And industry.

Mr Pierce—and industry, of course—so that they work together. There will be work that we will be undertaking, but we will be doing it in concert with the other two. The process that Jane referred to is reporting back to the Tourism Ministers' Council in April, and it is really from that point that decisions about how much funding—not only Commonwealth funding, but also resources from the states and in the industry—will sit behind each of those recommendations.

35. This question was answered during the Estimates hearing on 11 February 2010 (ref: Proof Committee Hansard, pgsE4-5). The relevant extract from the Hansard is provided below.

Senator EGGLESTON—I would now like to turn to the implementation of a national tourism accreditation framework working with relevant partners to improve the quality of tourism products and services. I understand this has not been put into operation yet. Is that the case?

Ms Madden—That is the case. As you know there has been extensive discussion and some progress on this accreditation framework. It is a key deliverable under one of the work plans of the National Long-Term Tourism Strategy and will be the subject of discussion at that forthcoming tourism ministers' meeting, which the secretary referred to.

Senator EGGLESTON—That was an election commitment of the Rudd government and two years have now passed. Would the minister like to comment on the commitment of the government to this program? Two years is quite a while.

Senator Wong—I am sorry, Senator?

Senator EGGLESTON—I am surprised that two years has passed without it being implemented.

Mr Pierce—Good progress has been made, particularly in the last couple of months. The starting position was essentially a lot of different accreditation frameworks across the country and different parts of the sector that were inconsistent with one another. It took a bit of time to get acceptance of the need for a national accreditation framework. Having got that acceptance, the work that is going on at the moment is really down to the mechanics of what is going to be measured, how it is going to be judged. It is going to be voluntary, so we have to convince people that it is worth the while of each individual business that it is going to help them to be part of this process. It is really not something that you can sit there and—I suggest it would not be successfully implemented if you just

try to dictate to the industry that this is what is going to happen. So the time up until now has been about bringing people along. I think that has been achieved. Now the discussions are around how to do it rather than whether to have it or not.

#### 36. No response required.

37A. The Department coordinates access to the online tourist complaint facility. The national online tourist complaint form and the national telephone complaints hotline are part of the Department's broader on-going work to market and strengthen tourist protection measures. The online complaints form is available on the Department's website (http://www.ret.gov.au) in Korean, Chinese and English. The Department continues to work towards making these forms more accessible. The Department also liaises with overseas authorities to ensure that information is hosted on or linked to sites easily accessible to overseas visitors.

The development of a National Tourism Accreditation Framework will also provide an opportunity to improve industry standards and professionalism, and enable consumers to more readily identify the quality of service and professionalism that a tourism business offers.

For leisure group tours covered by the China Approved Destination (ADS) Status scheme, the Government is actively enforcing ADS Code of Conduct requirements for Inbound Tour Operators approved under the scheme. The Consumer Hotline number and the Interpreter Service phone number are required to be included in all ADS itineraries. ADS tourists must be provided with a copy of their itinerary before travel.

- 37B. In 2008 and 2009, 163 complaints were lodged to State and Territory fair trading agencies through the national online tourist complaint form hosted on the web site of the Department. These complaints are actively pursued by the relevant State and Territory authority.

- 39. All indigenous tourism related activities are driven by the Indigenous Tourism Working Group, as part of the implementation of the National Long-Term Tourism Strategy. The Working Group, with representatives from Commonwealth and State government agencies and industry, has as its key current tasks:
  - Reviewing and indentifying gaps in existing government funding programs designed to assist in the development of Indigenous tourism businesses;
  - Development of quality Indigenous tourism product through addressing demand and supply side issues;
  - Promotion of Indigenous leadership in the tourism industry; and
  - Encouraging Indigenous employment in the tourism industry.

- 40. The Department of Resources, Energy and Tourism has engaged with key stakeholders on labour, skills and regulatory issues through a number of forums, including:

For example, following extensive consultation with both employer and employee stakeholders, as well as the Department of Resources, Energy and Tourism, Minister Gillard varied her award modernisation request on 28 May 2009 to require the AIRC to "create a separate modern award covering the restaurant and catering industry, separate from those sectors of the hospitality industry providing hotelier, accommodation or gaming services". The AIRC published the final Restaurant Industry Award 2010 on 4 December 2009.
