#### Senator Ryan asked:

How many self employed people made tax deductible superannuation contributions in the years: 2006-07, 2007-08, 2008-09, 2009-10 and how much did they claim?

If possible, can the ATO provide this data broken down by industry sector?

#### **Answer:**

The following tables provide the number of self employed people who claimed a tax deduction for personal superannuation contributions, the value of such contributions and a breakdown by industry sector. These figures are sourced from *Taxation statistics 2006-07, 2007-08 and 2008-09*.

It is too early for the ATO to provide this information for the 2009-10 year as some individuals still have time to lodge their tax returns in accordance with the Tax Agent Lodgment Program.
