Senator RYAN: If you could take that on notice that would be handy.

Mr Pearson: Yes, I can take that on notice and get it to you, because it will need a little bit of description for you to appreciate it.

Senator RYAN: I appreciate that.

#### **Answer:**

The ACCC monitors fuel prices on an ongoing basis. Regular reports are prepared for Commissioners and senior staff.

The report referred to by Mr Pearson on 15 February 2012 was on gross indicative retail differences for regular unleaded petrol in the eight capital cities to 31 January 2012. A copy of the report is attached.

Note that gross indicative retail differences are calculated by deducting average retail prices from average terminal gate prices (TGP).

### Petrol gross indicative retail differences – January 2012

This report provides an update of gross indicative retail differences (i.e. average retail prices less average terminal gate prices) for regular unleaded petrol (RULP) in the eight capital cities to 31 January 2012.

#### **Key points**

### Five largest cities

- The monthly average difference in January 2012 decreased by 1.9 cpl to 7.0 cpl.
- The average difference in 2011-12 YTD was 7.9 cpl, compared with 7.6 cpl in 2010-11.

#### By city

- Of the five largest cities, Brisbane had the highest average difference in 2011-12 YTD of 10.7 cpl, followed by Perth (7.7 cpl), Melbourne (7.1 cpl), Adelaide (7.0 cpl) and Sydney (6.9 cpl).
- Monthly average differences for January 2012 were:
  - o Down in Canberra (by 4.5 cpl to 10.9 cpl),
  - Hobart (by 4.0 cpl to 11.9 cpl),
  - Darwin (by 2.6 cpl to 15.3 cpl),
  - Sydney (by 2.2 cpl to 5.8 cpl),
  - Adelaide (by 2.3 cpl to 5.9 cpl),
  - Perth (by 1.8 cpl to 6.8 cpl),
  - o Melbourne (by 1.7 cpl to 5.7 cpl) and
  - o Brisbane (by 1.4 cpl to 10.6 cpl).



Chart 1: Gross indicative retail differences (cpl)–RULP, five largest cities–last 6 months



Chart 2: Nominal gross indicative retail differences (cpl)–RULP, five largest cities, 2006-07 to 2011-12 YTD



Chart 3: Real gross indicative retail differences (cpl)-RULP, five largest cities, 2006-07 to 2010-11^





### Attachment 1B

### Methodology

- Gross indicative retail differences in this paper are calculated by subtracting the period average terminal gate prices (TGP) from the period average retail prices.
- Retail prices are from Informed Sources and are collected for each day of the week.
- TGPs in Sydney, Melbourne, Brisbane, Adelaide and Perth are calculated from data provided by the four refiner-marketers plus data for Gull and (historically) Trafigura, for each day of the week.
- This is the same methodology that is used in the Petrol Monitoring Report.
- In Canberra the TGP for Sydney is used as there is no separate TGP available for Canberra.
- In Hobart and Darwin the TGP data is collected from the Australian Institute of Petroleum, which does not publish TGPs for weekends. Monday TGP prices have been carried backwards to Saturdays and Sundays. This methodology is used to best reflect the pricing policies of the companies.
- The Queensland state fuel subsidy of 8.35 cpl (around 9.2 cpl including GST) at the retail level was abolished on 1 July 2009. The TGPs in Brisbane prior to 1 July 2009 were reduced by 9.2 cpl to enable comparison of gross indicative retail differences on a consistent basis.
