ANSWER

1. The department receives information from the Office of the Australian Information Commissioner (OAIC) through regular emails and through the OAIC govdex site. Agencies, where relevant have provided the following updated advice.

ASQA receives regular newsletters from the OAIC which sometimes include advice on how to respond to FOI requests. ASQA has previously sought legal advice in relation to FOI, no legal advice has been sought in the reporting period.

AIMS monitors information provided by the OAIC via regular emails. This includes updates to guidelines, recommended templates for documents used in processing FOI requests and a variety of other information on FOI policy and administration. As at the 31 January 2013, no formal advice has been received by AIMS for the 2012-13 financial year.

The CSIRO monitors information provided by the OAIC via its Govdex forum. This includes updates to guidelines, recommended templates for documents used in processing FOI requests and a variety of other information on FOI policy and administration. As at 31 January 2013, no formal advice has been received by the CSIRO.

The Australian Research Council (ARC) monitors information provided by the OAIC via its Govdex forum. This includes updates to guidelines, recommended templates for documents used in processing FOI requests and a variety of other information on FOI policy and administration. The ARC receives regular emails from the OAIC, which sometimes include advice on how to respond to FOI requests.
