TOPIC: Relocation Scholarship

REFERENCE: Written Question – Senator Nash

QUESTION No.: AI-52

- 1. What is the eligibility criteria for relocation scholarships?
- 2. Are students eligible for independent youth allowance that move away from home also eligible for this payment?
- 3. The criteria include a dependent person who has to live away from home to study. What is defined as 'live away', is there a distance criteria, eg they need to live a certain distance from place of study?
- 4. Refer to QoN SI-127. Is the information for payments of the relocation scholarship for 2012 able to be broken down into the categories of student receiving the scholarship? For example those in receipt of ABSTUDY, those who are dependent and required to live away from home and those meeting specific independent criteria.
- 5. Please advise the number of students in 2012 receiving relocation scholarships who receive dependent youth allowance at a rate of \$6,000 and under.
- 6. Please provide a breakdown of figures on the number of dependent students in 2012 who were eligible for the relocation scholarship and received less than the full rate of dependent youth allowance.
- 7. Refer to QON SI-127 and to the relocation scholarship expenditure table at paragraph 3. Can this be further broken down to show how much of the total expenditure per Remoteness Area was directed to students deemed dependent?

ANSWER

- 1. The eligibility criteria for Relocation Scholarships are set out under Division 2, sections 592J-K of the *Social Security Act 1991*¹. In summary, to qualify a student needs to be in receipt of Youth Allowance (or ABSTUDY (Living Allowance))² and:
 - be a dependent student who meets the criteria for payment at the 'away from home' rate; or
 - if independent, meet specific scholarship independence criteria³; and

¹ For ABSTUDY, eligibility criteria are set out in the ABSTUDY Policy Manual.

² A student must be receiving some basic payment and more than just the Rent Assistance or the Pharmaceutical Allowance component to qualify for a Relocation Scholarship.

³ A student who is independent can qualify for a Relocation Scholarship if they receive Youth Allowance (or ABSTUDY (Living Allowance)) at the independent rate because of one or more of the following circumstances:

[•] they have, or have had, a dependent child who is, or was, wholly or substantially in their care; or

[•] they are an orphan; or

[•] their parents cannot exercise their responsibilities because they are in prison, missing, or are mentally incapacitated or living in a nursing home and likely to remain so for an indefinite period; or

[•] they are a refugee (unless they have a parent living in Australia, or are wholly or substantially dependent on someone else on a

- be enrolled and undertaking full-time studies in an approved scholarship course at a higher education provider as defined in the *Social Security (Approved Scholarships Courses) Determination 2010 (No. 1)*; and
- study for at least 35 days in the relevant scholarship period; and
- not be in receipt of, or not likely to receive within the following 12 months, a precluding payment such as a Commonwealth Accommodation Scholarship.
- 2. See footnote 3 in answer to 1.
- 3. A dependent tertiary student can meet the requirement of needing to live away from home through one of the following criteria:
 - travelling time between the parental home and the tertiary institution at which they choose to study is excessive;
 - the parental home is an inadequate place to reside while studying;
 - there is a compulsory requirement to reside at the tertiary institution while studying; or
 - they are undertaking part of their Australian approved course at an overseas institution.

Excessive travelling time is where the time it takes for the young person to travel by public transport from their parent's home to the tertiary institution exceeds 90 minutes, including walking and waiting times. Restrictions due to lack of, or deficiencies in, public transport can also be taken into account.

Data Descriptions

Includes the following recipients:

Dependent (DEP) and independent (IND) recipients of Youth Allowance (student) or ABSTUDY who have received a Relocation Scholarship payment from the Department of Human Services payment system for the 2012 calendar year. Data as at 6 March 2013.

Remoteness area distribution for the \$4000 and \$1000 payments is based on the recipient home postcode the fortnight before payment date using the Australian Standard Geographical Classification (ASGC) 2006 Postal Areas (POA) to 2006 Remoteness Areas (RA) concordance. Remoteness area distribution for the \$2000 payment is sourced directly from the Department of Human Services payment system.

Note: discrepancies may occur between the sum of the component items and the total due to rounding, caused by the use of a concordance.

Note: as home location is generally not an eligibility criterion for independent students, remoteness area distribution for independent students may not be an accurate reflection of their home location.

Note: as Relocation Scholarship data has been disaggregated into payment type and dependency status, there may be instances of double counting resulting in higher numbers than when the data is not disaggregated.

Note: In order to protect individuals' privacy, populations <20 are reported as "<20" and other data that would allow these populations to be derived are not provided "np".
