Letter from Minister Bailey to local governments and small business groups

Dear « Title»

I write to invite you to make a submission on the drafting of a new program designed to encourage the local government sector to press ahead with regulatory reform and the reduction of red tape with a view to specifically benefiting home-based businesses.

The Regulation Reduction Incentive Fund (RRIF) is being established with an initial Australian Government contribution of \$50 million, to provide financial support to local governments who are able to demonstrate initiatives that reduce the red tape burden.

A major objective of the RRIF is to promote economic activity at the local level so that employment prospects are enhanced and local communities prosper.

I am aware, of course, that local government regulation serves a variety of purposes such as community amenity, health and safety, and derives its power from state government legislation. It is not intended that the RRIF will in any way dilute the public benefit impacts of regulations, but provide local government with an incentive to review their regimes to test their efficiency and effectiveness, and minimise any unintended adverse impacts on home-based and small businesses.

The RRIF is a competitive grants program, meaning applications for funding will be assessed on merit against specified assessment criteria that will be developed as a result of this consultation phase. Guidelines for the RRIF will be developed in consultation with the small business community and local government. The program will be delivered by AusIndustry within the Department of Industry, Tourism and Resources and is expected to be operational in the 2005-06 financial year.

As part of the RRIF initiative, the Government will be producing a range of materials to assist local governments apply for funding. To further assist local councils, the Government will be providing examples of best practice regulatory reforms already implemented by local governments.

Many councils have implemented reforms already that could provide ideas to others. For example, the City of Marion in South Australia reduced the restrictions on employee numbers and floor space to reflect the reality that modern business practices and communication technologies allow sub-contracting and employment by people who do not work on site. In Victoria, the City of Casey has developed a range of reforms aimed at home-based businesses, including an on-line manual, covering areas such as getting started, promotion and government services.
