Senator SHERRY asked:

Could we be provided with a list of those entities? Obviously you cannot do that now.

Mr Cooper—I am sure we can do that for you.

Senator SHERRY—Perhaps we could have a little bit of basic information on where their headquarters are and who at a state level is responsible for their regulatory oversight, to the extent that state governments are responsible in this area. I must say there has been a lot of research from our point of view to try to identify which particular government departments, statutory authorities and entities at a state level are overseeing these trustee entities. There is an added on issue that they are operating interstate, which begs a fundamental question for another time.

Answer:

ASIC wrote to the Public Trustee of Queensland and 23 trustee companies on or about 4 September 2006. The table below is a list of these trustees and their registered office.

State governments are not responsible for the regulation of these entities in their role as debenture trustees. Section 283AC stipulates who can be a trustee for the purposes of Chapter 2L of the Act.

Trustee Obligations

I am writing to you in relation to your company's role as a trustee for debenture holders and in particular to bring to your attention a recent court decision involving a debenture issuer, Bridgecorp Finance Limited ('Bridgecorp').

In the Bridgecorp case (copy enclosed) ASIC applied to the court for orders under section 283HB of the Corporations Act 2001 ('the Act'). The consent orders made in that case follow a number of surveillances recently undertaken by ASIC in relation to debenture issuers, prospectuses and advertising. This is the first action taken under this section, and offers trustees a precedent to use when concerned about the position of debenture holders. Importantly Barrett J stated:

"Absent ASIC interest and involvement, however, it would be expected that the trustee might bring a matter such as the present before the court. The aim of the statutory provisions in this area is to stock the armouries of trustees so that they may be active in the protection of debenture holders."

Section 283HB of the Act also allows trustees to seek court orders regarding:

- **§** Restraining the borrower from paying any money to the debenture holders.
- **§** Restricting advertising by the borrower.
- **§** Restricting borrowing by the borrower.
- **§** The appointment of a receiver over property that is security for the debentures.
- **§** Enforcing the security for the debentures.
- § Staying an action or other civil proceeding before a court by or against the borrower or a guarantor.

When engaging with debenture issuers and products going forward, ASIC will continue to focus on the role of the trustee. In particular ASIC will consider the effectiveness of the compliance processes implemented by trustees in performing the important oversight role of helping to protect the interests of investors. Section 283HB is an important tool for trustees in this respect.

The Bridgecorp judgment is a timely reminder to you, as trustee, of the assistance you may seek from the court to assist you in fulfilling your duties, and we encourage you to take the opportunity to review your practices in light of that judgement.
