^{*} The stationery costs for 2009-10, 2010-11 and the 2011-12 financial year to date (as at 31 May 2012) are detailed in the table below. CSIRO has a streamlined its procurement practices and entered into an agreement with Corporate Express to be its prime supplier of stationery. The nature of the goods available and purchased under this arrangement is broader than stationery as defined above (i.e. paper, envelopes, with compliments slips) and includes photocopying and printing consumables, minor items of video equipment or other office machinery and small furniture items that are below CSIRO's asset threshold of \$3,000.
