Senator Murray provided in writing:

Please provide annual data for the last three years on expenditure on, and numbers of participants in, the Government's labour market programs for jobless people including: Job Network (with separate data on Intensive Assistance/Intensive Support/Customised Assistance respectively), specialist programs for people with disabilities (data for each program), and specialist programs such as Transition to Work and JET for parents and carers.

Answer:

Expenditure on Job Network (JN) for financial years 2001/2002, 2002/2003 and 2003/2004 are detailed in Table 1. JN job placement and commencement numbers for financial years 2001/2002, 2002/2003 and 2003/2004, are detailed in Table 2.

Expenditure and participant numbers for specialist programs for people with disabilities for financial years 2001/2002, 2002/2003 and 2003/2004, are outlined in Table 3.

Expenditure and participant numbers for Vocational Rehabilitation for financial years 2001/2002, 2002/2003 and 2003/2004, are detailed in Table 4.

Expenditure and participant numbers for Transition to Work for financial years 2002/2003 and 2003/2004, are detailed in Table 5. Transition to Work commenced on 1 July 2002.

The training element of the JET programme were subsumed into the new Transition to Work (TTW) programme following the 2002 Budget. The remaining elements of JET are the responsibility of the Department of Family and Community Services (FaCS).
