Please note in regard to the table that the take up rate in Victoria, Queensland and Western Australia, where education authorities did not inform parents directly or advised parents late in the pilot, the take up ranged from 12% to 30%. In States where parents were advised directly of their eligibility by the education authority the take up ranged from 47% to 70%.
